- All membership classes include one designated member, who represents the company, is entitled to one vote, receives all communications, may participate on committees and become a candidate to hold office.
- Purchase a two-year membership and save 10%.
- Purchase a three-year membership and save 15%.
- Standard membership includes designated member and up to four other FTEs.
- Add \$11 per FTE for sixth and all successive FTEs.
- Associate memberships, if not included in Chairman's Circle, President's Circle or Executive Club are \$219. Associate members receive communications and may participate on committees.
- 501.c(3) non-profit organizations receive Standard Membership at \$285 flat rate.
- All new membership investments require a one-time \$50 administrative fee.
- Memberships are held in the name of the business unless paid with personal funds.
- All memberships are continuous unless canceled in writing by the member, by the NLVCC for non-payment of dues or for non-compliance with NLVCC policies.
- Memberships are non-refundable.
- Memberships are the property of the NLVCC and must be returned if membership is canceled for any reason.
